#### **About the Program**

Many lawyers have never received formal training on how to determine if a witness is telling the truth or lying. As a result, they often struggle when faced with "he said/she said" allegations. Ironically, those who have been trained on how to spot deception using traditional methods actually do worse than those who have not been trained - because they are trained to look for deception cues that are not in fact valid.
