

**Egil "Bud" Krogh** is a Senior Fellow on Ethics, Leadership, and Integrity at the Center for the Study of the Presidency and Congress in Washington, D.C. He served as Deputy White House Counsel from 1971 to 1973. During the five years between his disbarment from law practice in 1975 and his reinstatement to the bar in 1980, Mr. Krogh taught Ethics, Public Policy Analysis, and Administrative Law at Golden Gate University in San Francisco.

Bud is co-author, along with his son Matt Krogh, of the book, *Integrity: Good People, Bad Choices and Life Lessons from the White House* (2007, Public Affairs), and is a highly sought after, international speaker on the topics of decision-making, legal ethics, and personal and professional integrity.
