About the Program

The ability to improvise - in any setting - can often mean the difference between success and failure for a lawyer. Think on the Spot! is a fun, interactive seminar that applies the "Eight Rules of Improvisation" - the same skills actors and comics use on stage - to the communication challenges lawyers face every day. Lawyer and improvisation performer Toni Halleen will use proven improv skills to help participants discover and hone their own thinking and communication habits, and strengths. Learn how to listen, respond to the unexpected, collaborate, generate new ideas, build trust and agreement, and speak with confidence when you're under pressure. The worlds of improv performers and lawyers are more similar than many people think. Don't miss this unique opportunity to learn while you laugh and enhance multiple skills critical to the practice of law.

Topics Include

Using the principles of improv, you'll explore the tools that enhance effectiveness for lawyers, including:

- Listening and concentration
- Changing gears on the spot
- Trusting one's instincts and experiences
- Holding multiple concepts in mind
- Expressing ideas and adding to others' ideas
- Being effective under pressure
- Gaining trust and confidence
- Remaining open to ideas and challenge

What to Expect

This seminar is designed to build your confidence by teaching you to think outside the box, approach scenarios from many angles, and react evenly when something unexpected happens. After an introduction to the basic eight principles, you'll get up on your feet other participants, and using exercises, with techniques and games of the improv performer, you'll practice responding to the unexpected. Along the way, you'll laugh and have fun. At each stage, Toni will lead the group in a discussion of the exercises and the application of verbal and non-verbal learning to daily professional life. A key component of the workshop will be the connection between the exercises, the skills being developed, and the daily work of lawyers.
