### **ABOUT THE PROGRAM**

Psychological assessments play an important role in a wide range of civil and criminal cases including child custody cases, mental competency hearings, personal injury cases, and professional negligence actions. A large number of these assessments are composed by primary care physicians, social workers, nurses and other professionals who are not court-experienced, are not well-versed in the hard and soft science aspects of psychology research, are not sufficiently familiar with the applicable assessment measures, are not clear about the nature and importance of assessment validity, and have limited knowledge about the unreliability of memory and truth assessments.

This 75 minute teleseminar, co-presented by a lawyer and a court accepted psychological expert, aims to better familiarize you with these key areas for questioning so you can more quickly and effectively challenge unqualified opinion evidence dressed up as expert evidence. You will learn:

- how to expose the witness' unfamiliarity with psychometric validity
